In connection with our letter to you of August 21, 1962 we have now received from the State Department of Public Instruction a copy of the acknowledgment of another order by the Dodge County School Committee. This order dissolves School District No. 15 of the Town of Lowell, 69-0362094, effective June 30, 1962 and attaches the territory comprising the district to the Beaver Dam district.

The state will now take steps to terminate the OASDI agreement with the Social Security Administration on behalf of this district as we did for the four other districts listed in our letter of August 21. It follows of course that if there are any additional personnel to be included for social security coverage as a consequence of the attachment of the district named above to your district, they should be included on subsequent quarterly reports for Joint School District #1 of the City of Beaver Dam, et al.

The wage report for the June 30, 1962 quarter was the final social security report to be submitted to this office by the dissolved district. No reporting forms for the September 30, 1962 quarter were furnished to this district because we had known of the dissolution of the district prior to the time the forms were distributed.

It is assumed that the file copies of all quarterly reports and adjustment reports for the dissolved district have been turned over to you along with the other records from the district so that the proper information will be available in the event a correction of wage information for the dissolved district is necessary.
